Subject: Issues related to the executives of EZBC, transferred from WBTC to CTD- reg.

Respected Sir,

It is to draw your kind attention to some of the problems, in view of inclusion of EZBC, Kolkata, under Kolkata Telephone District, w.e.f. 01.06.2019, as a separate BA, headed by PGM.

You may be aware of the fact that a lot of executives right from J.T.O./J.A.O. level, have been transferred to C.T.D. from WBTC establishment. It is true that various teething problem have been cropped up after shifting of EZBC unit-II CTD, which need to be resolved at the earliest by CTD administration, in tandem with the counterpart of WBTC. The problems are depicted below:

1) Transfer of GPF balance:

GPF balance of incumbents are to be transferred by DOT cell/WBTC to DOT cell/CTD immediately. PGM/Finance/WBTC & Sr. GM/Finance/CTD may be requested in this regard to take up the issue vigorously with appropriate authorities for early settlement.

It is noteworthy that some of the executives viz. Sri Sandip Kr. Das, CAO and Sri Vinoy Bhusan Chakraborty are going to retire in the next month, whose LPC , GPF balance, Service Book are to be collected from the previous establishment for timely settlement of terminal benefits.

2) Settlement of GPF withdrawal and advance cases :

Executives working in EZBC/Kolkata are facing difficulties at the time of GPF withdrawal/Advance due to non-transfer of GPF account to CTD. These cases may be taken care of.

3) Issue of LPC and release order by WBTC:

Early settlement of the issue may please be taken care of by PGM/Fiance/WBTC & GM/HR/WBTC to keep their service book updated.

4) **Updation of service book:**

Updation of service book like pension contribution, GSLIS contribution, Leave account etc. with service verification, should be updated upto 31st May,2019, by the previous circle/unit head and immediately handed over to the CTD authority.

5) **Issue of BSNL MRS card and Identity card:**

The concerned units of CTD may please be instructed properly for issuance of new BSNL MRS /Identity Card to all executives of EZBC/Kolkata, who are transferred in CTD.

6) **Confirmation order of DR. JTO/JAO batch 2015:**

Early compliance in this regard, is highly solicited. Action may kindly be taken by GM/HR/WBTC.


7) **Upgradation of scale under EPP:**

Upgradation of pay scale of executives now working in EZBC, may kindly be expedited

In consultation with the previous circle i.e., WBTC , so that the effect may be given by CTD in time. Updated vigilance clearance upto 31.05.2019 may kindly be obtained i.r.o. executives transferred to CTD Circle from WBTC .
