**Respected All India President, Beloved GS, our own colleague OS(E) and other CEC members,**

**I have the privilege to place Interim Report of CS/CTD since my taking over as CS from 22/04/2017 to till date.**

**In the meantime, team AIBSNLEA/CTD took part in all the programmes called by AUAB against the sinister move of DOT & Govt. Of India. This includes two days' All India Strike on 12 & 13<sup>th</sup> December, 2017 which was 100% successful throughout CTD. Our BSs & all the COBs & Gen.members played a pivotal role in this respect. As per call of AUAB, we submitted memorandum to the Hon'ble Rajya Sabha MP Ms.Rupa Ganguli and the Hon'ble MP of Sreerampur Sri Kalyan Bandyopadhyay. We also submitted memorandum to the office of Hon'ble Governor of West Bengal.**

**We have attended three All India meetings at Jaipur on 01.12.17, at New Delhi on 28<sup>th</sup> and 29<sup>th</sup> June, 2018 and CWC at Dehradun on 18<sup>th</sup> and 19<sup>th</sup> August, 2018. Participants of CTD played their important roles in those meetings by pointing out some major problems of BSNL as well as CTD.**

**In this respect, we must recall the illustrious role of our beloved GS Com.Prahlad Rai in issuing promotion orders of almost 12,000 Executives of different cadres viz. JTO to SDE(Both LDCE & SCF), SDE to DE, JAO to AO, DGM(Finance) Adhoc to Regular, JTO to SDE(Electrical & Civil) and SDE to EE(Electrical & Civil). But due to some reasons or other, much awaited AO to CAO promotion, though issued on 21/11/18 till now not implemented fully. GS is requested to take care of this matter. In this connection, we would also like to mention SDE to DE (List No.8), DE to DGM and JTO to SDE promotions are eagerly awaited.**

**AD(OL) upgradation case is also another feather in our cap. But we request clarification of date of effect of this order. We demand, the date of effect should be 28/06/2018 on which date DOT has cleared the matter.**

**We would like to mention that JTO(Offtg.) FR 22-1 (a) 1 is not implemented in true spirit by giving Fixation with Pay Protection. Some personal cases of CTD are still pending. We request CHQ to expedite the cases. The list of these cases will be separately submitted to GS.**

**In a short spell, we have met Madam Director(HR) on 14/12/17, 24/03/18, 14/06/18 , 27/07/18 and 14/09/18. We handed over well written memorandums and discussed various items elaborately (copy of which submitted to CHQ).**

**In the mean time, we have conducted three CEC meetings on 23/11/17, 04/08/18 and 20/11/18 and Circle Office Bearer meeting on 27/02/18. On 09/04/18 we conducted a Special GB at CTO Hall, Kolkata where our beloved GS graced the occasion. In this connection, we would like to mention that all our activities are being updated in our Circle Website on regular basis.**

**CS and sometimes OS(East) attended the Open Sessions of Conferences of BSNLEU , SNEA, AIGETOA and SNATTA as a token of fraternity amongst the Executives and Non-Executives.**

**Time to time we met Administration of CTD like CGM, GM(HR), GM(Finance) and respective PGMs to solve our day to day problems. CS also written some letters regarding the development of CTD and suggestions thereof. Field units of CTD are also facing acute cash crunch now a days , for which payment of Electricity Bills and other payments are severely affected.**

**The main problem of JCL wages payment in CTD has not been settled till date and now it has become the most burning issue. It should be sorted out immediately; otherwise the growth of revenue of CTD will be severely shattered.**

New CGM , CTD has took over charge on 1<sup>st</sup> December,2018 from his predecessor Sri S.P.Tripathi. We met him and assured all our co-operation for the development of CTD. New GM(HR&Admin) also joined few months back. We met him also.

IIM(Ahmadabad) Team visited CTD for the survey of the revival plan of BSNL. Our Team met them and presented an elaborate proposal.

Before I conclude, I must extend my sincere thanks to CHQ, Circle Body and Branch Leadership for extending all kinds of Co-operation to me in discharging my duties. I hope younger members will come forward and take the leadership to a new height to upheld the philosophy and legacy of our beloved AIBSNLEA.
